1 ELECTION OF TOWN MAYOR FOR 2017/18

Outgoing Town Mayor Cllr Hester thanked the Town Council for the honour of being elected Town Mayor for 2016/17. It had been hard work, and he offered his thanks to Members for their support.

Two candidates were nominated for the position of Town Mayor 2017/18:

Cllr Sallie Stuckey: nominated by Cllr Seward, seconded by Cllr Bull

Cllr Barry Hester: nominated by Cllr Turner, seconded by Cllr Murphy

In accordance with Standing Order 1.19, the outcome was decided by written ballot, and Cllr Stuckey duly elected as Town Mayor for 2017/18. Cllr Stuckey signed the Declaration of Acceptance of Office, countersigned by the Proper Officer, and took the chair for the remainder of the meeting.

Two candidates were nominated for the position of Deputy Mayor 2017/18:


Cllr Mary Seward: nominated by Cllr Bull, seconded by Cllr Choudhury

A notice for the vacancy arising from the resignation of ex-Cllr Canham had been issued, and expired on 12 June.
