10. Estimates 2015/16. Two options are included in the pack, with different assumptions on the fallout from the JD Wetherspoon offer. The first assumes that rented accommodation is sourced, and indicates an increase of £0.59 in the cost per household. The second assumes repayment of a Public Works Loan of £600k over 25 years, with repayments of around £36k per year (estimate based on Cromer Town Council repaying a £500k loan at £32k per year over the same period) – this results in an increase of £6.35 per household. Further information regarding Cromer's approach to purchasing its offices is being sought.
