#### 8. DOG AGILITY

It was decided to defer a decision on agility equipment until the position of a new Dog Park has been agreed. It was suggested that an area in Woodville may be suitable and is worth investigating, but the viability of other areas are also worth considering and residents should be asked for their thoughts.

#### 9. SEATS IN THE MEMORIAL PARK

A resident contacted the office to ask if the Council could place more seats in the Memorial Park but as proposed by Cllr Wright and seconded by Cllr Felstead it was **RESOLVED that there were enough seats** already present within the Memorial Park and no further action would be taken.

#### 10. HAPPISBURGH ROAD STREET LIGHT

As proposed by Cllr Hester and seconded by Cllr Sims it was **RESOLVED to agree the costs involved in replacing the broken light and arm on the Happisburgh Road Streetlight** 

#### 11. CHAPEL DOOR AND FLOOR

As funds have already been agreed for cleaning the Chapel Floor it was agreed that Medieval Masonry should commence work as soon as possible.

A remedial quote is to be sought for the removal of the old Varnish from the Pews

Following review of the Absolute Consultants Survey as proposed by Cllr Wright and seconded by Cllr Felstead it was **RESOLVED** to get quotes to address the Infestation problem and the Insulation needs of Poppies.

#### 13. CEMETERY WALL

Following the Cemetery Wall being demolished we are awaiting confirmation that costs to rebuild will be coved by the Insurers. Once this is received the wall will be rebuilt allowing for better visibility when accessing Bacton Road.

Quote will be sought for a further retaining wall.
