NNTPF Update 30—07-21

To all Town and Parish Clerks and Councillors

Please find below the latest update from the North Norfolk Town and Parish Forum

Second Homes

I am sure all of you are busy dealing with the ongoing impact of COVID and the high numbers of visitors to the area. With the growing popularity of staycations the issue of second homes and holiday lets (SH/HL) and the impact they are having on our communities has been highlighted. I must first point out that the NNTPF is not against SH/HL. We appreciate how dependent our tourist-based economy is on this housing option. However, we must look at the ways we can mitigate the impact on our local communities, housing for local need and the sustainability of our communities. It is to this end which the Forum is working.

We recently met with Duncan Baker MP and the Minister for Housing the Rt Hon Christopher Pincher MP (MHCLG)In this meeting it was stressed the community appreciated the changes to the 140 days ruling but still awaited on the detail before reserving judgement as to how effective this would be. It was also stressed about the need for affordable rentals for the area since even with a 30% reduction from market price so called affordable shared ownership homes are not affordable with an income to housing ratio ranging across the area from 1:12- 1:16

The Minister was interested in our ideas for mitigation and requested we send in more information and our suggestions regarding this. The letter which we sent via Duncan Baker and with his support is attached.

Eg; Norfolk County Council, NNDC, local land owner, local business and whether this is beyond your parish settlement boundary or not. We can still influence this however and in an area where core spending for the council is being reduced year on year and a high number of elderly people, poor rural transport and significant number of SH/HL, local authorities are dealing with additional costs. It is important therefore, that the cost drivers within the formula do reflect the true cost of the provision of services and support for our specific area.
