### 7. NORTH WALSHAM IN BLOOM

As proposed by Cllr Wright and seconded by Cllr Bull, it was **RESOLVED to grant, although** retrospectively, permission for North Walsham in Blooms' shed to be located in the cemetery.

Letter to be written to North Walsham In Bloom to remind them that they are responsible for the insurance and maintenance of the shed.

No permissions to be granted in future, without the full prior agreement of the Clerk and the Chair of D&A.

It was noted that Cllr Murphy objected to the granting of permission, pointing out that the area was earmarked for Car Parking in the Cemetery.

#### 8. CHILDRENS AREA IN CEMETERY

It was not felt necessary to highlight the Baby Garden area of the Cemetery and unanimously agreed that placing a sign or relevant statue in the area would cause unnecessary grief to the families of those interred there. As proposed by Cllr Murphy and seconded by Cllr Golder, it was **RESOLVED NOT to place any signage or statue within the Baby Garden** 

### 9. **SKATE PARK COMPLAINTS**

Letters to be written to Residents in response of concerns.

- 1. (Complaint about danger of dogs running near skate Park) to install a sign reminding people to keep dogs on leads.
- 2. (Complaint that residents were given no notification of instalment of Skate Park) Confirm that North Walsham Play have: over 100 press cuttings regarding the build, placed details on social media platforms and in the town guide, that NWP have been transparent with details at both town council and annual town council meetings, and been present at the big bash.
- 3. (Safety concerns regarding children crossing the Bypass) Confirm that we are working with the County Council to address the crossing issue

As proposed by Cllr Wright and seconded by Cllr Gray, it was **RESOLVED to write to residents** highlighting the above points, install the 'Dogs on Leads' signs, place an additional piece of fence at the new entrance to the park to act as a slowing gate and to take to Full Council the idea of running an additional fence from 'Fence to Fence' across the park (Bypass to Railway)

### 10. UK POWER NETWORKS

As proposed by Clir Wright and seconded by Clir Gray, it was **RESOLVED to accept the quote for cable to be used in the Memorial Park as supplied by Anglian Electrical**
