6. STAFFING MATTERS

6.2 It was decided to accept Michael Buller's request to reduce his hours from 37hrs per week to 34.5hrs per week on medical grounds

As proposed by Cllr Heinrich and seconded by Cllr Gray, it was **RESOLVED to approve the request** for reduced hours, by 2.5 hrs per week starting 1 June 2022
