8.1 To consider co-option vacancy

Two applications were received, and a vote was taken. By majority vote, it was **RESOLVED that Clir Richardson be co-opted for the Councillor vacancy in the North Ward** (Declaration of Acceptance of Office form was signed)

8.2 To consider applying for street furniture licenses for the Battlefield Trust

It was discussed that following land owners permission being granted and confirmation that the Battlefield Trusts will take responsibility for the noticeboards, it was proposed by Cllr Wright and seconded by Cllr Bull, it was **RESOLVED** to apply for a street furniture license for 5 noticeboards on behalf of the Battlefield Trust

8.3 To consider bid for Parish Partnership 22/23

8.4.1 A heat source pump was recommended as a new heating system, however due to the construction of the building, it would need to be confirmed with Lee West that it would ne sufficient insulation to make use of the heat source pump effective. It was AGREED unanimously to leave the final decision to ClIr Bull, ClIr Wright and the Clerk

8.4.2 Due to Health and Safety, and ventilation issues, the decision was made to **APPROVE the quote for new windows from Andy Brown and go ahead**
