As proposed by Cllr Wright and seconded by Cllr Bull, it was **RESOLVED** to install 3 new signs at Trackside stating that dogs must be kept on leads at all times and 1 sign in the dog park stating that residents enter at their own risk as dogs will be running off lead. The 3 dogs on lead signs would be positioned at two pedestrian gates at the Station end of the park and one on leaving the dog park into the main park. FC to investigate wording
