7. HEAD GROUNDSMAN REPORT :

(a) Trackside Shelter

It was reported that a quote had been obtained to remove the shelter which was acceptable.

As proposed by Cllr B Hester and Cllr B Wright it was **RESOLVED**

That the quote should be accepted for removal of the shelter

(b) Signage at Trackside

A sign was produced for consideration to be placed at Trackside with rules for dog users.

Some amendments were made but the format of the sign was agreed.

Cllr G Bull had previously confirmed that the signs could be purchased (from Council budget).

The Head Groundsman would arrange and order the signs.

(c) Chapel Door

The poor condition of the door was detailed which needed filing, priming and painting.

As proposed by Cllr I Jackson and seconded by Cllr A Fryer it was **RESOLVED**

That three quotes would be obtained for this work.

8. NORTH WALSHAM PLAY :

Mr M Smith informed members of the following :

(a) Update on outside gym

He advised that the work would commence on 18 July 2019 and would take 4 days with the wet pore being laid on 23 July 2019. The keys and beverages would be available at Poppies as arranged.

(b) Skate Park Update

He reminded everyone about the Skate Park Meeting at Costa Coffee on 12 July 2019 when four design plans would be available to consider. The actual Skate Park structure was of metal and concrete. He understood from NCC a computer based crossing was being considered to be installed.

9. CHAIRMAN UPDATES

The Chair reported the following updates :

- (a) Placement of Notice Boards in the wards. Replies were still awaited from the three convenience stores in the Town. Deferred to next meeting when responses should have been received.
- (b) Road Signs. A list of signs with costings from NCC was produced.
As proposed by Cllr B Wright and seconded by Cllr B Hester it was **RESOLVED**
That the road sign "Road Closed" be purchased
- (c) Street Light Numbering – The numbers are to commence being placed on the street lights.
- (d) Bier plaque – This had been ordered and placed on the bier.
- (e) Tap at the Memorial Park Allotments – This item is on the Agenda for the next Community Centre Meeting after which the allotment holder will contact us with the outcome.
- (f) Ridge signs – A quote had been produced for the signs. It was agreed that A4 signs were needed. The Head Groundsman will arrange.
- (g) Street Lights at Memorial Park. These will be commenced on 22 July 2019.

10. ANY OTHER BUSINESS

- A static CCTV camera is to be placed in the Memorial Park.
- The painting of the bus shelters were to start next week by the schools. However, with the scrapping off of the existing paint work and white wash painting to be carried out by grounds staff, this would be delayed. The school holidays were imminent. Various other options for carrying out the scrapping and white wash were considered.
