As proposed by Cllr Seward and seconded by Cllr Wright the minimum reserve figure to be £120,000 **[ACTION WM]**.

As proposed by Cllr Seward and seconded by Cllr Wright the preliminary works for the welfare unit in the cemetery grounds to be charged to capital cemetery reserve.
